#### The role

The European Board of Veterinary Specialisation (EBVS) plays a vital role in elevating the standards of veterinary care across Europe by certifying veterinary specialists in fields like surgery, internal medicine, pharmacology, public health, and more. Established in 1992, EBVS ensures that specialists meet rigorous standards, thereby enhancing animal care quality and supporting public health, animal welfare, and food safety.

### **Certification and Benefits**

EBVS certification allows veterinarians to gain advanced qualifications beyond their veterinary degree, requiring at least four years of intensive postgraduate education and <u>training</u>, followed by a comprehensive examination process. Certified individuals earn the title of European Specialist<sup>M</sup>, recognised for their expertise and commitment.

## **The Impact of Veterinary Specialists**

Veterinary specialists are essential in addressing complex medical cases and safeguarding public health. For example, specialists in <u>infectious diseases</u> and <u>epidemiology</u> are crucial for monitoring and controlling outbreaks, thus protecting both animal and human populations from health risks. These specialists uphold ethical standards and contribute significantly to animal welfare.
